### Legal Help for Rape and Sexual Assault Survivors

Sexual assault survivors often reach out to VRLC needing help with multiple complex legal issues. VRLC attorneys provide a wide range of expertise across several areas of law and do so with a trauma-informed approach. This enables survivors to get help on a variety of legal needs all in one place - VRLC.

Massachusetts: VRLC attorneys focused on expanding safety protections for survivors. Staff attorneys collaborated with local firms to build our capacity to manage appeals in civil protection order matters and to protect our clients' private records during the criminal prosecution of their perpetrators. Our efforts saw staff argue before a three-member panel of the Massachusetts Court of Appeals for the first time as well prepare for a Single Justice appeal. Staff attorneys also collaborated with organizations statewide to provide feedback on proposed edits to the 258E Harassment Prevention Order for survivors of non-intimate partner violence. VRLC advocated to expand the available protections so that survivors of non-intimate partner violence can have the same safety precautions available to survivors of intimate partner violence, including firearm forfeiture for 258E defendants.

Oregon: VRLC attorneys continued to provide critical legal assistance to rape and sexual assault survivors in Clackamas, Multnomah, and Washington counties. The primary legal practice areas requested by survivors were education law and immigration law. Our team also created and distributed an Oregon Civil Protection Order chart, which has proven to be a valuable tool for attorneys and victim advocates across the state to determine which type of civil protection order best applies to their clients. This chart will serve as a template to explore jurisdiction-specific protection orders throughout the country in the future.

Both Oregon and Massachusetts VRLC offices moved in 2022! Each office is now located in easily accessible parts of downtown Portland and Boston respectively. As we emerged from pandemic restrictions, it has been exciting to meet clients in our new offices as well as at community partner sites.

#### VRI C on Sexual Violence in Antarctica

VRLC, as part of a larger team, worked for two years on issues of sexual harassment and assault within the U.S. Antarctic Program (USAP), culminating in an eye-opening review. In August 2022, the National Science Foundation's Office of Polar Programs published **a report** on sexual assault and harassment in USAP. Since its release, the high prevalence of sexual assault and harassment in the USAP has come under intense scrutiny by Congress, major news outlets, and science publications. In collaboration with the National Science Foundation's Office of Polar Programs, VRLC spent several months in Antarctica facilitating a series of listening sessions, analyzing survey responses, and launching a confidential advocacy program for the USAP community to improve the response to sexual violence in this unique setting. Our work on the ice continues to help make the USAP a safer environment.



## Strengthening the National Response to Sexual Violence

Our National Training and Consultation program is far-reaching, creating a ripple effect nationwide. Throughout 2022, VRLC's National Training and Consultation team provided training, mentorship, and consultation to 1,750 attorneys, advocates, higher education professionals, and other service providers in 51 U.S. states and territories. VRLC's team of experts conducted these trainings and consultations under three Office on Violence Against Women funded projects: the Sexual Assault Justice Education Project; Legal Empowerment Advocacy Project; and the Student Conduct Dating, Domestic Violence, Sexual Assault, and Stalking Capacity Building Project.

VRLC closely collaborated with numerous partners, including the National Housing Law Project; El Programa Hispano Católico; Aequitas; Clery Center; Stalking Prevention, Awareness, and Resources Center; National Organization for Victim Assistance; and the Oregon Coalition Against Domestic and Sexual Violence. Trainings included advocacy for survivors in the criminal justice system; deliberate sanctioning practices; understanding the toxicology of alcohol-facilitated sexual assault; a small group cohort specifically for supervising attorneys; and much more. Following several of these trainings, the team also conducted Share and Learn calls, which provided the unique opportunity to discuss case- and program-specific questions as well as build relationships with other attorneys and advocates nationwide who have encountered similar challenges.

VRLC attorneys launched and distributed guides and resources that hundreds of attorneys now use each year to better serve survivors of sexual violence, stalking, and dating violence. In 2022, we created a Legal Pleading Bank, and updated our much sought after Legal Practice Manual. We also produced a 40-minute training video to enhance the questioning techniques of higher education professionals in dating and domestic violence cases.

VRLC's national program engages in policy work that directly impacts not only VRLC clients but all sexual assault survivors. In 2022, we submitted a public comment to the U.S. Department of Education in response to proposed Title IX changes under the Biden administration. The comment states in part, "The proposed regulations address some of the most insidious aspects of the current regulatory regime. We offer this comment to help guide and facilitate changes that would strike the appropriate balance of equity and fairness from a trauma-informed perspective. Our sincerest hope is that student-victims will not be afraid of reporting sexual assault to their school and be able to trust again that Title IX provides an effective remedy."



#### Pro Bono Partnerships

Pro bono attorneys and legal paraprofessionals are essential partners to VRLC in both Massachusetts and Oregon.

#### Serving Survivors Locally...

A survivor going through the criminal justice process had a decade's worth of her medical, mental health, and social media records requested by defense counsel representing her assailant. She didn't feel comfortable continuing with the criminal case, as it was a serious invasion of her privacy. A VRLC pro bono attorney represented the survivor and was able to significantly limit the selection of records supplied for the trial. The survivor felt like her privacy was protected and was able to comfortably engage in the remainder of the criminal case against the perpetrator leading to a conviction.

#### ...and Impacting the Movement Nationwide

Law firms Goodwin; Manatt, Phelps & Philips; and Shook, Hardy & Bacon assisted VRLC on several large projects. These firms contributed thousands of pro bono hours researching timely topics such as sexual assault protection orders related to when rape results in pregnancy; reporting of non-accidental injuries; jurisdiction-specific work on privacy for minors, adults, elders, and those who are disabled; the rights of attorneys (or lack thereof) to question and/or depose crime victims; and seeking post-conviction relief for survivors of gender-based violence. This research informed our staff attorney's representation of numerous survivors.




# Thank you to our volunteers, donors, and award recipients for an extraordinary celebration!
