## Joining Forces with the American Bar Association

VRLC and the American Bar Association Commission on Domestic and Sexual Violence are collaborating on a project focused on integrating a trauma-informed approach to legal services. In August, VRLC Deputy Director Amanda Walsh facilitated a roundtable of anti-sexual violence organizational leaders to discuss ways they prevent harm to and promote the wellness of attorneys, intake staff, and clients they serve.

## **Supporting Protections for Survivors**

The VRLC submitted **testimony** earlier this month in support of Massachusetts' Harassment Prevention Law (258E). It has been over 10 years since 258E was enacted. This bill closes gaps in protections for survivors seeking relief under and expands access to these orders by including trafficking as a basis for relief and ensuring that judges can remove firearms from respondents in related cases.
