Support Survivors Now: Release Federal Funding!

Sexual assault and domestic violence are dominating headlines nationally. From abuse committed by elected officials to civil rights leaders, to survivors once again being forced to publicly relive trauma while seeking accountability, to drug-facilitated rapes by husbands to rape academy websites, to mass homicide of children and murder-suicide, the message is clear: gender-based violence remains deeply embedded in our institutions, culture, and systems of power. This violence disproportionately impacts women and girls and marginalized populations, including people of color, LGBTQ people, immigrants, Native Americans and people with disabilities.

The scale of domestic and sexual violence we are witnessing is relentless. In fact, it is unfolding at an all-time high during April, Sexual Assault Awareness and Prevention Month — a time to honor survivors and renew our commitment to prevention and justice. Meeting this commitment includes ensuring all survivors have equal access to safety, justice and healing— requires a national movement to end gender-based violence and federal funds to support victim service programs working on the front-lines.

Victim service programs, including rape crisis centers, domestic violence shelters and community-based programs addressing gender-based violence, are challenged in meeting our national commitment due to unprecedented cancellations and delays in federal funding over the past year including:

- **Significant delays in the release of FY25 U.S. Department of Justice (DOJ) Office on Violence Against Women (OVW) grants, including over \$200 million in federal funds appropriated by Congress** through the bipartisan Violence Against Women Act (VAWA). OVW grants provide critical funding to rape crisis centers on college campuses, domestic violence shelters, community-based programs, and prosecution-based programs to support investigating and prosecuting sexual assault, domestic violence, and stalking, among other life-saving programs to prevent, intervene, and respond to gender-based violence across our nation. Victim service programs have now been waiting over **7 months** for the release of these federal grants, as the scheduled award date was October 1, 2025.
- **Delays in the release of new funding for FY26, including the failure to release the FY26** OVW Notice of Funding Opportunities (NOFOs) for grants to support domestic violence, dating violence, sexual assault, and stalking programs nationwide.
- **Terminations of federal funding to support victim service programs, including over 365 DOJ grants totaling over \$811 million terminated in April 2025.** A majority of these grantees who appealed their termination have yet to receive any response from the DOJ over 11 months later.

The need for victim services and the cost to provide them rises every year. Victim advocates support survivors of sexual violence, domestic violence, stalking, human trafficking, and families impacted by homicide and other violent crime. They answer crisis calls, accompany survivors to hospitals and courtrooms, secure emergency shelter and safe housing, navigate complex legal systems,

connecting them to legal remedies and protections, stabilize their education, and help survivors begin recovery after unimaginable harm.

And yet these services are limited because of staff layoffs caused by the termination or delay of federal grants last year and extended delays in the release of federal funds that have been appropriated and, in some instances, obligated.

Current federal funding instability caused by the U.S. Department of Justice is creating uncertainty for local programs already stretched thin, having to plan for furloughs or ultimately layoffs of the very people who care for survivors. This funding instability is directly related to the escalating sexual and domestic violence we are experiencing every day across the country.

These are not distant policy debates. They are personal. Every fatality and headline can reopen wounds. Every public failure to hold perpetrators accountable sends a chilling message. The lapse and cuts in funding tells survivors their safety is negotiable. That their lives are negotiable. But they are not.

Domestic and sexual violence is not inevitable. It is preventable. Accountability is possible. Healing is possible. A safer society is possible. But only if we are willing to prioritize it and invest in it.

It means recognizing victim advocates as essential professionals who provide life-saving crisis and recovery care, not invisible labor. It means ensuring no survivor is turned away because a shelter is full, or an agency cannot afford another staff.

We must demand accountability everywhere harm occurs — in our homes, workplaces, schools, communities, and the highest levels of government. No title, office, bank account, or position of influence should place anyone beyond responsibility for committing domestic and sexual violence.

This Sexual Assault Awareness and Prevention Month, awareness alone is not enough. The U.S. Department of Justice must immediately distribute the federal funds that Congress appropriated and release the notice of funding opportunities for programs to sustain life-changing and life-saving services. Not in the months to come — today.

Survivors need safety and action now, and those of us who support them demand it.

Survivors' lives depend on it.
